Requirements and information

- All applications must be accompanied by proof of lawful presence in the U.S. See "Change in Aurora Water's Rebate Requirements."
- Program applies to Aurora Water account customers in good standing.
- Those customers living in a multi-family dwelling served by Aurora Water are also eligible.
- Rebates are only given for washers meeting the criteria of the Consortium for Energy Efficiency (CEE) for High Efficiency (HE) clothes washers.
- Washer must be installed in an Aurora Water account residence.
- Limit one washer rebate per Aurora Water account address.
- The rebate amount cannot exceed the actual cost of the washer.
- An inspection may be required to verify the replacement of your washer.
- Your water account will be credited for the amount of the rebate.

- To qualify for the program, your receipt needs to be dated between 1/1/08 and the end of the program year. Rebate program is first come, first served. Limited funds are dedicated for the program each year. When funds are exhausted, the program ends.

Change in 2007 Aurora Water's Rebate Requirements

House Bill 06S-1023, signed into law by Governor Bill Owens on July 31, 2006, restricts who may receive public benefits in the State of Colorado. Anyone 18 years of age or older must prove lawful presence in the United States in order to receive non-emergency public benefits.

This law applies to Aurora Water's Rebate Programs. In order to apply for a rebate, we now require the additional submission of the **Affidavit of Lawful Presence in the United States** with a copy of one form of identification as described below:

- a valid Colorado driver's license (includes only a **current** driver's license, minor driver's license, probationary driver's license, commercial driver's license, restricted driver's license, or instruction permit),

Note: The Colorado Department of Revenue allows us to accept a driver's license from the District of Columbia and the following states: Alabama, Arizona, Arkansas, California, Connecticut, Delaware, Florida, Georgia, Idaho, Indiana, Iowa, Kansas, Kentucky, Louisiana, Maine, Minnesota, Mississippi, Missouri, Montana, Nevada, New Hampshire, New Jersey, New York, North Dakota, Ohio, Oklahoma, Pennsylvania, Rhode Island, South Carolina, South Dakota, Virginia, West Virginia, and Wyoming.

- a valid Colorado identification card,
- a United States military card,
- a United States military dependent's identification card,
- a United States Coast Guard Merchant Mariner card,
- a Native American tribal document,
- a naturalization or citizenship certificate,

Submit the completed affidavit and your copied identification with the other required rebate paperwork. Your identification materials are not considered public record and will remain confidential.
