- III. <u>ADOPTION OF AURORA COMMISSION FOR SENIORS MINUTES:</u> The Minutes from April 1, 2019 were approved with a motion by Jeannie Davis and a second by Gloria Shea

VI. OLD BUSINESS

- Ronald Roulhac updates the commissioners on the Aurora Senior Forum.
 - o The Forum will be held on Friday, October 11th from 9:00 a.m. until 1:00 p.m.
 - This year we will be increasing exhibitors from 47 to 65 and will have exhibitors stationed in the front lobby.
 - We will not serve breakfast this year but we will offer coffee, juice and light snacks. These will be served throughout the building in various area. This will allow for better traffic flow and will offer more exposure to the exhibitors.
 - o We will provide lunch, it will be served in room 111.
 - Deborah Burcham is working on obtaining sponsorships for the Forum.
 - The Aurora Commission for Seniors will need to determine the theme of the Forum and the topics to be addressed by the speakers.
 - Last year we had three presenters, this year we will only have two.
 - Jeannie Davis proposes that the, "Sisters of Charity of Leavenworth" speak at the forum. They are a non-profit group and offer, "The Aging Mastery Program" which covers fall prevention, cyber security, social connectivity, nutrition, fitness, and chronic disease management. The program also includes a kit for each participant which has resource guides, memory cards, DVDs, and progress charts.
- Juanita Audre asks about the status of the proposed ACS candidate nomination form that was sent to City Council, Ronald Roulhac states that he hasn't heard anything yet.
- Juanita Audre wants to set up a By-Law review. Ivy Hontz mentions that the ACS has a video presentation of the by-laws. She volunteers to go through the video to see which slides are current and which slides need to be removed. Ronald Roulhac says that he will find and deliver the video to Ivy.
- Juanita Audre advises the commissioners to review the commission report, which will be presented on Tuesday, May 21, 2019 at 4:00 p.m. The document is distributed to each member and is thoroughly
