# **FINANCIALS**

Mr. Arney went over the balance sheet and budget comparison for all Aurora Housing Authority properties, Aurora Housing Authority Fund, and Housing Choice Voucher Programs.

Commissioner Neely made a motion to approve the financials. Second by Commissioner Huffman. Motion carried.

#### **HCV Administrative Plan**

Ms. Morris requested approval from the board to update the HCV Administrative Plan to reflect the revisions to the Nan McKay plan by HUD, and to include the addition of 40 Mainstream Vouchers.

Commissioner Neely made motion to approve AHA Board Resolution #564 Approving Revision of the Section 8 Housing Choice Voucher Administrative Plan. Second by Vice-Chair Suh. Motion Carried.

**Fitzsimmons Veterans Project Low-Income Housing Tax Credit Application Authorization** Ms. Ashley-Oehm discussed updates on the Fitzsimmons Veterans project, and requested approval and authorization to apply for Low-Income Housing Tax Credit.

Commissioner Huffman made motion to approve AHA Board Resolution #568 Authorization Applications to the Colorado Housing and Finance Authority for an Allocation of Low Income Housing Tax Credits and to the Colorado Division of Housing and the City of Aurora for Grant Funds and Designating Signatory Authority. Second by Vice-Chair Suh. Motion carried.

## **Dissolution of AHA Finance Corporation**

Ms. Han requested the approval of the Aurora Housing Authority Board of Commissioners to dissolve the Aurora Housing Authority Finance Corporation.

Commissioner Neely made motion to approve AHA Resolution #566 Approval of Proposal and Recommendation to Dissolve AHA Finance Corporation. Second by Vice-Chair Suh. Motion carried.

As the Aurora Housing Authority Finance Corporation, Commissioner Neeley made a motion to approve Resolution #567 authorizing the dissolution of the Aurora Housing Authority Finance Corporation. Second by Commissioner Huffman. Motion carried.

# **Discuss Dates for VWC Completion Event**

Mr. Maraschky informed the board of commissioners of potential dates for the VWC completion event, explaining that the last week of July or the first week of August are being considered.

#### **New/Other Business**
