At the Commission meeting on December 11, 2018 the Civil Service Commission unanimously voted to extend the 2018 Sergeant certification list by 55 days. The Commission cited budgetary concerns as the primary reason for this Charter-authorized extension. Therefore, the 2018 Sergeant certification list will now expire October 4, 2019 or upon certification of a new list.

The Sergeant written exam will be tentatively moved to Wednesday, August 21, 2019. The Sergeant assessment center will be tentatively moved to September 17-19, 2019. A promotional notice will be published in formally announcing these dates and the reading list for the written exam.
