15. Significance Statement

Trolley Trailer No. 610 of the Denver Tramway Company is an artifact from the expansive years of the Denver metro area streetcar industry. This industry started from horse-drawn city streetcar lines. With the advent of electrically powered trolleys, the companies were able to expand their service out of the larger cities and into the suburbs and rural areas. Trailer 610, was an non-motorized car towed by a motorized trolley car and was used to relieve congestion during peak traffic times. Trailer No. 610 was constructed by the Woeber Car Company in Denver in 1913 and weighed 18,300 pounds, held 50 patrons seated, and 100 standing. The trailer body measures 8'4" wide, 40'8" long, and 8' 4 1/8" high.

15. Significance Statement - continued

No. 610 was used on several lines including Line 14 until 1932 in Aurora up to the Geneva St. "wye". The Fitzsimons Bus and Taxi Company began operation in 1919 and provided transportation from the Geneva St. "wye" to Fitzsimons. In 1929 the line became a subsidiary of the Denver Tramway Company. From that point forward the companies were less prosperous, and the trolleys and services reflected the austere conditions of the companies. Aurora was served by bus service after that date. No. 610 is documented in the Robert and Sue Parkhurst Photographic Collection (Colorado Railroad Museum), as photographed in January 1, 1923 and is featured in *Denver's Street Railways Vol. II*, by Don Robertson and Rev. W. Morris Cafky.

In October 1932 the Trolley was assigned to the Denver & Intermountain Railroad, the Tramway's standard-gauge interurban line to Golden, where it was used to transport WPA workers assigned to Red Rocks Amphitheater and to Camp George West Station in Golden. After World War II the bus system in the metro area put the streetcars out of business. In the 1940's the Fitzsimons Bus and Taxi Company merged with the Denver Tramway Company. When the Trolley was no longer needed by the Denver Tramway Co. the trucks and other equipment were removed, and it was sold to Dr. Edwin Perrott for \$50 in 1950 and was moved to their family property in east Aurora on the northwest corner of East Colfax and Airport Road. In time a house was constructed around No. 610 that was later rented out by the family. The trailer, enclosed in the house, was protected from the elements and remained on the Perrott farm for 56 years. In 2006 William Perrott, son of Edwin, donated the trolley to the Aurora History Museum and it was removed from the site. The trailer is now housed in a warehouse where it is being restored by the Aurora Museum Foundation. The Trailer is an excellent example of tramway rolling stock.






