#### I. Call to Order

A quorum being present, Chair Gordon Tucker called the Historic Preservation Commission (HPC or Commission) meeting to order at 6:30 p.m.

#### II. City Survey Software (Heroku) Demonstration

Stelios Stylianou gave the HPC an explanation of the chronos interactive software used as a survey tool.

### II. Staff Report

Historic Preservation Specialist Drake Brownfield gave his report to the Commission

**Section 106 reviews**: No historic properties affected.

**Landmark Brochures**: Landmark brochures, which include the newest landmarks, are being updated.

**Chris Geddes**: Chris has resigned from the HPC as she no longer lives in Aurora. The HPC is grateful for all Chris did while an HPC Commissioner.

**Windler Homestead**: The owners of the Windler Homestead located at Green Valley Ranch Boulevard and Piccadilly Road. may be willing to pursue a historic designation. There may be an adaptive reuse of the barn as well.

Geocache: A geocache has been established at the Bicentennial Arts Center.

Gulley Shed: Jacob has researched the history of the Gulley shed. The build date is between 1920 and 1950. A decision about what to do with the shed needs to be made.

**Oral History**: The Aurora History Museum has requested stories of religious diversity in Aurora.

Royal Villa Cottage Court HABS Level II Assessment: No new information

**Coal Creek School**: Hopefully, the Certificate of Occupancy will be awarded soon. The floor has been inspected and the contractor is working on the final list of repairs.

**Newspaper Digitization Project**: The cost to finish this project is \$22,000. Commissioner Evans requested that the Aurora Sentenial be asked to run the donation form requesting that Aurora residents pay \$1.00 a page to help finish the project.

**Red Cross Project**: Updated drawings are expected soon. Signage will remain a part of the project, though some of the landscape items will be eliminated to cover the cost of the signage.

**Loafing Shed**: The concrete work is complete. The HPC funded this work.

**Budget**: The current budget is \$2,008. A determination on how to spend the rest of our budget will be an action item for the November meeting.

#### **IV. Old Business**

**Lowry 880**: Commissioner Tucker will contact former Commissioner Geddes to find out where the project stands.

**Firehouse #5**: A landmark nomination is planned for 2021.

**Fox Signage**: The project is on track. Public works will monitor the grant. The project should start early 2021.

**KOA Building**: The KOA building is considering historic signage and adding a QR code to the sign.

**Subcommittee Reports: Events Subcommittee**: The committee will work with the Aurora news channel to educate the public.

## **DeLaney Farm HD Outbuilding Paint Project Funding**

Drake Brownfield, Historic Preservation Specialist requested that the HPC pay \$1,500 for paint, and scraping, and priming for the outhouse, long barn, shed, and chicken coop.

A motion was made by Commissioner Ackman to approve the request and seconded by Commissioner Berens. The motion passed by voice vote.

**Historic Line Drawing:** Commissioner Henke created an historic line drawing as a gift for former Commissioner Bailey. A copy of the drawing can be put on the museum website as a coloring page.

**HPC Meeting Time Change:** A suggestion was made to start the November HPC meeting at 6:00 p.m. rather than 6:30 p.m. The HPC agreed to start at the new time next month.
