**Abstract:** Since its earliest days, even when known as Fletcher, the city of Aurora has sought to acquire a steady water supply. As the city expanded in population and area, the search for additional water sources became even more crucial. The Aurora Water Collection documents the city's continued efforts to provide water as well as treat and dispose of waste water.

**Arrangement:** The collection begins with the history of Aurora's water acquisition from the end of the nineteenth century to the beginning of the twenty-first. Details of specific projects for transporting water from the mountains to the plains include right of way acquisition, costs, and construction of reservoirs and tunnels. The Homestake Project makes up the largest part of this section. The last part of the collection documents problems of storm drainage and sewers. Five folders contain material on Denver Metropolitan Water and regional water issues.
