Abstract: Citizens may present petitions to the City of Aurora upon collection of a certain number of signatures from citizens of the city of legal voting age. Petitions in this collection general address issues of street safety, noise, recreational and civic facilities, and residential land use and zoning.

Arrangement: It is unclear when the petitions were first organized. These files are being separated from other municipal files, and re-organized in 2013 using the dates and order previously used. The petitions are maintained in one series.
