- **Abstract:** On June 16th, 1965, severe thunderstorms hit Eastern Colorado. The city of Aurora was also hit by a tornado. Subsequent damage to roads, public utilities, and bridges (especially at Peoria and 30th) ran to roughly \$300,000. This collection covers the application process for state emergency relief funds allocated by House Bill 1002, including receipts, work orders, and payroll records needed for an state audit of expenses. City of Aurora Director of Civil Defense Mr. O. James Murray was appointed as the city's representative in July 1965, and most correspondence in the file takes place between Murray and the State Natural Disaster Coordinator Major General Joe C. Moffitt and Deputy Coordinator James L. Rappe.
- **Arrangement:** The collection is maintained in its original order as best as possible. The series is headed by documents pertaining to the original cost estimates and documents justifying each work project. The remainder of the collection is then organized by line items in the state's emergency fund application. Line 1/"A" corresponds to debris clearance. Line 2/"B" corresponds to preventative health measures. Line 3/"C" is the largest subseries, describing work on roads and bridges. Lines 4, 5, and 6 ("D," "E," and "F") outline expenses for dikes and levees, public buildings, and utilities in that order. "Basic" refers to original fund applications regarding damage which happened on June 16th, 1965. "Supplemental" refers to additional application materials submitted in regards to recurrent flooding in July 1965, after the president extended the time frame for emergency relief.

Series 1: State Emergency Relief Fund application

Folder 1: Paperwork starts right after the flooding in June 1965 with the first expense reports from the Water Department. Mr. O. James Murray is appointed to handle all dealings with the state during the application. Various health authorities vouch that certain projects are necessary for public health, and early cost estimates are made for each line item for the City in Adams, Douglas, and Jefferson Counties. An initial application is

submitted in August 1965, later amended with project C-16 after the president expanded the emergency dates. Final budgets for each line are included at the end.
