## **Transportation - Trolley Collection**

## **Collection Summary**

**Title:** Transportation -Trolley

Abstract: Trolleys emerged as a form of public transportation in Denver in the 1880's. By 1888, a line had extended into Montclair and was converted to an electric line in 1889; shortly thereafter the line was purchased by Aurora developers Donald Fletcher and Samuel Perry. Trolley route 14 ran between Denver and Aurora until 1950. Led largely by private restorer Joe Garrett, a group of citizens authorized by the Aurora Chamber of Commerce organized in 1975 as the Citizens Trolley Advisory Committee to reestablish limited trolley service in Aurora as part of the Bicentennial celebration. The collection documents the efforts of the committee, and the continued interplay between trolleys and revitalization efforts, both in Aurora and Denver.

Arrangement: This collected accumulated from different sources over the years. Where the source was known, the documents have been kept together. Otherwise, the collection has been ordered thematically first, and then by region. Box 1 contains clippings, correspondence, posters for CTAC, newsletters and drafts, internal documents from CTAC, collected legal documents (photocopied), hand drawn and photocopied maps, laser print and photographic images, blueprints, stickers, a cloth patch, a ribbon, and pamphlets. Box 2 contains a ten page photo album with 4x6 photos, Polaroids, and clippings, and twelve 11x14 inch scrapbook pages with photos and trolley tickets. Box 3 contains editions of various trolley and transportation magazines, as well as issues of American History Illustrated.

### **Subseries: News clippings**

**Folder 3:** Newsprint and photocopied clippings from April 1972 to January 1976, arranged chronologically. Subjects include Joe Garrett's restoration work before C-TAC, the development of C-TAC in 1975, the restoration of car 770, and funding issues around the Bicentennial projects. Sources include the *Aurora Sentinel, East Suburban Scout*, the *Daily Journal*, the *Denver Post*, and *Metropolitan News*.

# Subseries: Joe Garrett biography Folder 4:

- Booklet of printed images, probably autobiographically assembled by CTAC president and trolley restorer Joe Garret. Includes his military portraits from 1949 and 1982, photos of trolley car restoration projects (cars #312, 770, 54, and 109), ads for his painting business, business cards, a letter to *Traction: Prototypes & Models*, and a copy of *The Track Record* dated 1990.
- One ten page photo album with clippings and photos detailing a lawsuit brought by neighbors
  Jerald and Terry Brown in 1975. Sources include the Aurora Sun, the Aurora Sentinel and the
  Denver Post. Probably assembled by Joe Garrett (oversize, stored in Box 2).

# **Subseries: Trolley organizations post-CTAC Folder 5:**

- Drafts of the Aurora Central Electric Company newsletter in sleeves, including photo prints of cars 109 and 106, dated 1940's. One of the sleeves contains a patch for Colorado and Southern Railroad Company. Probably created from December 1976 to 1980.
- Educational drawing of proposed light rail car.
- Full version of Denver Central Electric Railway newsletter *The Track Record*, dated January 1981 which contains several letters from co-founders Joe Garrett and RTD historian James Kunkle. Also, pasted draft of pages.
- Printed list of members of the Denver Rail Heritage Society, dated March, 1990.
- News clippings (2006) regarding RTD light rail service in Aurora, trolley proposals on Colfax

- Research materials, including business registries for the area by the history trolley turnaround, site photos, and photocopied pictures of the old turnaround at Poplar Street.
- Clipping regarding funding.
- Public Places press release dated Nov 2, 2004.
- Artist's rendition of the project site.

- Newsprint and printed online clippings dated 2006 to 2010. Coverage follows the discovery, transport, and restoration of car 610, which was found in an Aurora farmhouse after police responded to a vandalism call in January 2006.
- Correspondence between the Aurora History Museum, the Aurora Trolley Commission volunteer group, the State Historical fund, and city agencies regarding historical designations, restoration work, funding options and applications, and the final placement of car 610 at the AMC campus
