Reminder on Laws - Upcoming 420 Events

Here are several reminders regarding laws pertaining to marijuana in Aurora:

- No Delivery of Marijuana to persons under the age of 21. Delivery is only permitted to a private residence and cannot exceed more than one ounce of recreational marijuana in a single day.
- No Public Consumption: Violation of State and Local Laws
- No consumption on a marijuana or liquor licensed premises is permitted in Aurora. Aurora does not permit marijuana hospitality lounges or private membership clubs.
- Product purchase is limited to one ounce of retail marijuana. Note that violations have been given for knowingly permitting looping where a purchaser leaves briefly and reenters. This is not permitted.
- Advertising is not permitted to be false, deceptive, or misleading and cannot appear in media where more than 28.4% of the target audience is under 21. Targeting minors is prohibited.
- No free samples are permitted and marijuana can only be sold on a licensed premise unless through permitted delivery to a private residence.

Change in Beneficial Ownership Applications

Any ownership changes (CCBO & Changes Exempt from CCBO) are to be reported locally when changes are made, even if the MED only requires notification at time of renewal. We are seeing an influx of unreported changes locally. Amendment forms and requirements for Aurora Marijuana licenses are found on the website Marijuana and Hemp Licensing - City of Aurora (auroragov.org)

Re-inspection Fees

Re-inspection fees for any failed marijuana inspection is \$200 for the first re-inspection and \$400 for any subsequent re-inspections. Fees will be invoiced on the license record and due within 7 days to maintain a current license

status. See the November newsletter on our website regarding common inspection failures to make sure you avoid these fees and operate in compliance.
