Once detained in the patrol vehicle, the driver saw a photo of the wanted party on the MDC screen and advised Member 1 and Member 2 that was a different person. Member 1 then cleared the driver and confirmed they did not have any outstanding warrants. Member 1 and Member 2 notified a sergeant of the incident, but failed to include the sergeant's name and TZH in the call notes. Member 1 and Member 2 also failed to complete a CDC report for the incident.</p>
