Bids received after the stated date and time will be returned to the Contractor unopened. Late Bids will not be considered for award.

Each bid shall be submitted along with the prescribed forms supplied with the Bid Package. The Bid shall include an itemized breakdown on the Description of Work prepared by Community Development on behalf of the property owner. Each item shall be inclusive of all overhead, profit and general condition costs.

The contractor promises, in submitting his Bid, upon notification, they will within the prescribed time, execute the contract agreement and furnish the required Licenses and Insurance Certificates. Failure to provide such Licenses and Certificates (i.e. SAM/DUNs) may result in a cancellation of the Contract award and the next most responsive Bidder will be awarded the Contract.

The Property Owner reserves the right to reject any and all Proposals, to waive informalities and irregularities, and to accept that Proposal which is considered to be in the best interest of the Owner. **The work is on a project associated with a program providing direct financial assistance from HUD and is subject to Davis-Bacon Wage Rates and the requirements of Section 3 of the Housing and Urban Development Act of 1968 (12 U.S.C. 1701u as amended.**
