By submitting this document, you acknowledge that you had an opportunity to discuss the legal ramifications of filing this document with legal counsel had you chosen to do so.

Section 3.3 of the Aurora city charter establishes the following qualifications for elective office:

"Each Council Member when elected shall be a registered elector, shall be a citizen of the United States of America, and shall have resided in the City of Aurora for at least one year prior to the date of the election and shall have reached their twenty-first birthday prior to the date of the election. Council Members elected from wards shall also be one-year residents and registered electors of the respective wards from which they are elected. A person who has been convicted of a felony shall not become a candidate for, nor hold elective office. No Council Member shall hold any other elective public office nor be a salaried employee of the City of Aurora."

By my signature, I certify that I meet all of the provisions set forth in Section 3-3 of the City Charter as being qualified to hold elective office in the City of Aurora, Colorado, effective as of the date of this application. I further acknowledge the City may take whatever action or request documentation as deemed necessary to determine that I am qualified to hold elective office in the City of Aurora, Colorado.
