

DISCOVER THE AURORA Water-wise Garden

Aurora Water-wise Garden History

When 2002 brought a drought of historic proportions to Colorado, Aurora was struggling with record-low snowmelt (95% of the city's water supply is from snowmelt). At the time, the new Aurora Municipal

Center had a landscape plan that was designed years before the drought and included large expanses of bluegrass. City officials knew they needed to send a clear message of water stewardship and that the traditional landscaping plan would accomplish this. The idea to create a xeriscape garden at the municipal center instead of 10 acres of rolling bluegrass was implemented.

The garden was installed in spring of 2003, as the city ordained planting restrictions through Aurora, permitting only "xeriscape plants and no sod." Today, we have moved away from the word "xeriscape," preferring to use "water-wise," but the mission of the garden and Aurora Water has remained the same.

Aurora Water-wise Garden Now

As the largest botanic garden dedicated to the practice of conserving water in the state of Colorado, environmental stewardship is one of the core values in the Aurora Water-wise Garden. Incorporating Colorado natives and native cultivars with non-native species, the garden supports over 200 animal species. Aurora Water-wise Garden is honored to be recognized by the Audubon Society as a Habitat Hero Garden. As a Plant Select Showcase Garden, you will surely find plants designed to thrive in high plains with less work.

Aurora Water-wise Garden uses little supplemental water. When we do, we irrigate with reclaimed, non-potable water from Aurora's Sand Creek Reclamation Facility. Reclaimed water is treated but not suitable for drinking. Our garden is proud to join Aurora's parks, golf courses and open spaces in conserving the city's drinking water by irrigating it with reclaimed water.

Wildscape in the Garden

Wildscape is landscaping with the purpose of supporting wildlife. We find that water-wise landscapes are diverse ecosystems that support many animals instead of a monoculture of grass that support few. You will be surprised at the variety of wildlife found inside the Aurora Water-wise Garden. From mule deer to coyote, to red-tail hawks to rabbits, to Monarch butterflies and bumble bees, our garden is alive.

Much of our landscape maintenance takes Wildscaping into account. As a volunteer in the garden, you will be encouraged to follow our practices—balancing traditional land management with organized horticulture.

HOW TO BECOME A WATER-WISE GARDEN VOLUNTEER

Our Aurora Water-wise Garden volunteers must register with the city of Aurora **volunteer portal**.

- Volunteers over the age of 18 must do a background check, the cost of which is covered by the city of Aurora.
- Volunteers under 18 must have a parent/guardian fill out a volunteer waiver agreement. Find it at the end of this handbook or email aslover@auroragov.org for a digital copy.

VOLUNTEER OPPORTUNITIES



POLLINATOR COUNTING

June - September | Training Required

Have you considered all the animals that co-exist with our plants? Help us gather more information about the pollinators that live in the garden, what plants they prefer most, building a greater understanding of pollinators in our garden. The Pollinator Count is held weekly on Saturdays. Volunteers must attend training, register, and

commit to a minimum of two pollinator counts per month. Volunteers may be asked to use iNaturalist app.

GARDENS A TO Z

April - October | No Training Required

Gardens A to Z is a variable general maintenance and care with activities varying from prepping new displays, deadheading, minor trimming, weeding, composting, picking up litter, seed harvesting, seed sorting, evaluating plant health, spreading mulch and general care of the six-acre Aurora Water-wise Garden. Each task will be demonstrated before volunteers dive into the work, so no training is required.

NEW! WEEDING WARRIOR WEDNESDAY

May - September | Training Required

Do you have a passion for pulling? Do you enjoy the deep meditation of weeding? This volunteer opportunity is the one for you. We need weeding warriors! Aurora Water-wise Garden has a weed focused day each Wednesday starting in May. One hour of training on weed identification and disposal is required. Look for the training dates in the

VOLUNTEER OPPORTUNITIES

COMPOST ALLIANCE

April - October | Training Required

Green waste is a big factor in landfill methane, a known contributor to greenhouse effects. Help AWG be a more sustainable garden by joining the Compost Alliance.

Composters will manage our large compost area through chipping, chopping, turning, watering, taking temperature readings, applying plastic and

sifting. Compost volunteers are required to attend trainings, found in the volunteer calendar **Aurora Waterwise Garden volunteer portal**.



NATIVE BEE WATCH, COLORADO STATE UNIVERSITY (CSU)

June - September | Training Required

Join the CSU Native Bee Watch in the Aurora Water-wise Community Garden. This program is run by CSU and all participants must experience the CSU training.

Native Bee Watch is a citizen science program to learn more about the native bee populations. Aurora Water-wise Garden is an important site as the bees in the Arapahoe county are underrepresented in state numbers. Training is provided through CSU and participants will be alerted to it.



SEED HARVESTING

September - November | Training Required

Aurora Water-wise Garden will be harvesting seeds for saving, distributing, and propagation within the garden and off-site. Volunteers must be trained to follow the procedures, standards, and ethics of the garden.

SEED CLEANING AND PACKING


November - December | No Training Required

VOLUNTEER AGREEMENT

This is a Release of Liability | Please read carefully before signing

In return for being allowed to participate in the City of Aurora ("City") Volunteer Activities and all related Activities, including any Activities incidental to such participation ("Volunteer Activities"), the undersigned Volunteer and Parent/Legal Guardian of Volunteer if Volunteer is under age 18 ("I", "me", or "my") releases, discharges and agrees not to sue the City of Aurora or its elected and appointed officials, employees, agents, representatives, sub-contractors, sponsors, and affiliates from all present and future claims that may be made by me, my family, estate, heirs, or assigns for property damage, personal injury, or wrongful death arising as a result of my participation in the Volunteer Activities wherever, whenever, or however the same may occur. I am voluntarily participating in the Volunteer Activities with knowledge of the danger involved, and I agree to accept all risks of participation. I understand that participation in the Volunteer Activities involves certain risks, including, but not limited to, serious injury and death. I understand and agree that the City is not responsible for any injury or property damage arising out of the Volunteer Activities, even if caused by negligence or otherwise, but the City agrees to pay up to \$1,000 for my reasonable and necessary medical treatment for my injury incurred during the course and scope of my Volunteer Activities. I also agree to indemnify and hold harmless the City for all claims arising out of my participation in the Volunteer Activities. I understand that this document is intended to be as broad and inclusive as permitted by the laws of Colorado and agree that if any portion of this Agreement is invalid, the remainder will continue in full legal force and effect. I also acknowledge that the City has not arranged and does not carry any insurance of any kind for my benefit or that of Volunteer (if Volunteer is under 18), my parents, guardians, trustees, heirs, executors, administrators, successors and assigns. I further understand that the City of Aurora will not provide me with any pay, compensation, insurance, workers' compensation or any other benefit to which an employee may be entitled. I represent that, to my knowledge, I am in good health and suffer no physical impairment that would or should prevent my participation in Volunteer Activities. I also understand that this document is a contract which grants certain rights to and limits the liability of the City to reasonable medical treatment of no more than \$1,000. This Agreement may only be amended, modified or supplemented by a written agreement signed by both parties, and any of the terms of this Agreement can be waived only by a written document signed by the party or parties waiving compliance.

Notice of photography and filming: By attending a City of Aurora Volunteer Activity, you are entering an area where photography, audio and video recording may occur. By signing this agreement, I consent to the City of Aurora photographing and/or recording me and using my image and voice in its publications.
