

Waiver and Release for Punkin Chunkin Colorado

1. I desire to participate in Punkin Chunkin Colorado, located at Arapahoe Park Racetrack, 26000 E. Quincy, Aurora, Colorado 80016. I understand, accept, and assume the risks associated with participation in any and all activities associated with Punkin Chunkin Colorado.
2. I assume full responsibility for any injuries which may occur to me, including, but not limited to: strains, sprains, pulls and tears of muscles or muscle tissue; dizziness; and injury to the spine, neck or back. Additionally, I assume full responsibility for any injuries to anyone on or associated with my team, any persons participating in the event, and any spectators resulting from my willful or negligent actions, errors or omissions. I do hereby fully and forever discharge and release the site landowner (Mile High Racing & Entertainment Company and Mile High Racing at Arapahoe Park), its employees, officers or agents, and the City of Aurora, Colorado, its elected officials, officers, agents, employees, authorized volunteers, representatives, and their successors and assigns (collectively, the "Released Parties") from any "Claims" arising out of my participation in this event.

"Claims" as used in this document means any and all claims, demands, damages, rights of action or causes of action, present or future, whether the same be known, anticipated or unanticipated, resulting from or arising out of my participation or the participation of my team members, our actions at the event, the use or intended use of the Arapahoe Park Racetrack site to chunk pumpkins with a Punkin Chunkin Colorado machine, and/or participation in activities connected with the Punkin Chunkin Colorado event including, without limitation, any of the foregoing resulting from or arising out of the negligence of a Released Party. Further, I hereby waive any and all "Claims" against a "Released Party."

3. I have received, read, and understand the Punkin Chunkin Colorado Safety Rules.
4. **During Practice Rounds and Chunking Rounds, access to the pit area will be limited to those team members and pit pass holders who have signed this Waiver and Release.**
