Other Notes & Requirements:

This piece will be the Closing for both Beg-Adv Recitals on June 7 & 8 (again, once our official Recital dates have been finalized).

*Dancers are only allowed <u>TWO EXCUSED ABSENCES</u> from Sunday rehearsals. We have already allotted for no rehearsal on March 31 (Easter), May 5 (Picture Day), May 12 (Mother's Day) & May 26 (Memorial Day Weekend). Any rehearsal absence must be pre-approved by Ms. Maggie, so if you have pre-existing conflicts with the rehearsal schedule, please communicate those when you accept your casting. An exception to this is extenuating illness, which should also be communicated. Fewer absences are preferable for the process. Absences result in delays in the choreographic process. If you cannot commit to the rehearsal schedule and these absence expectations, please do not accept your casting!

*Please note that this Closing is a very large piece that will be divided into smaller sections along with a couple of full ensemble sections. ALL DANCERS are required for the first two rehearsals on Feb. 18 & 25. After the first two rehearsals, Ms. Minda/Ms. Michelle have divided their piece into multiple sections with different dancers cast in each section. Dancers will only need to attend those rehearsals in which their section is called, and ALL DANCERS are required any time it is stated ALL CALLED in red.
